On the first item: IDF President Vladimir Langin reported on the IDF delegation's participation in the Congress of the International Association of Sport for all TAFISA in Budapest (Hungary) October 15-16, 2015, the adoption of the IDF International Draughts Federation as members of TAFISA, and the prospects for cooperation.

On the second item: Calendar of official events for 2016 is reviewed and approved. The application of Georgia for holding the European Championship 2016 among men and women and the application of St. Petersburg for hosting the European Youth Championship in 6 age groups have been approved. The participation of the International Draughts Federation in the Games of TAFISA on 6-12 October 2016 was discussed.

On the third item: The applications for holding the World Cup stages and the Regulations for the World Cup 2016 have been approved.

On the fourth item: New documents for 2016 have been reviewed and approved:

1. Conditions for holding of official competitions of the International Draughts Federation (IDF) in 2016-2018.
2. Regulations of the official draughts-64 competitions of the International Draughts Federation (IDF).

On the fifth item: Due to the fact that Section-64 (Russian-Brazilian) left the FMJD on 16.10.2015 and the International Draughts Federation (IDF) is now working independently, the Technical commission is tasked with developing all the necessary regulatory documents. First of all, it is necessary to finalize Official rules of the game and the competition in draughts-64.

On the sixth item: We need to start independently to assign titles to players and judges. The Technical Commission was instructed to work out the rules for assigning international titles to players and judges by the next meeting. Prior to the approval of these documents, it was decided to award titles according to the current regulations. The FMJD leadership refused to consider the titles in draughts-64 at a meeting in Tallinn and on the General Assembly of FMJD in Izmir. In this regard, the IDF Board approved the fulfillment of the norms for the past years, submitted by the Technical commission taking into account European Championship 2014, World Cup in St. Petersburg 17-26.10.2014, EYC Yaroslavl 2015, WYC Bulgaria 2015- to 45 players and judges.

On the seventh item: International Grandmaster Yevgeny Kondrachenko (Belarus) sent his proposals to the Technical Commission for discussion on holding official draughts-64 tournaments and new draw tables for men and women. It was decided to conduct a survey of federations and leading players on the systems of official competitions of the International Draughts Federation and draw tables for official competitions before January 31, 2016.

On the eighth item: Due to the withdrawal of Section-64 from the FMJD, whose legal entity was the International Draughts Federation (IDF), and the departure from the abbreviation fmjd, on the instructions of the Technical Commission a new official website of International Draughts Federation (IDF) (www.idf64.org) is being developed. It is almost ready and will begin work in January 2016.

Due to the fact that the information on draughts-64 on the official website of the International Draughts Federation (IDF) is already being watched from more than 170 countries, was noted the importance of using the official Internet resource for publishing all official information on it, fully informing both members of IDF and all other interested persons on the activities of the International Draughts Federation.

It was decided that with the launch of the new site in January 2016, all official information of the International Draughts Federation (IDF) will be published on the official website of the International Draughts Federation www.idf64.org. The publication on the site of IDF decisions is their official publication. Decisions of the IDF Board will be mandatory for IDF members from the moment they are published on the official website.

On the ninth item: Various issues of international activity (WADA, TAFISA) and current activities for 2016 were considered.
