Vsevolod Teterins proposed holding one of the stages of the 2025 World Cup in Europe. A discussion took place.

Altynay Jumagaldiyeva talked about draughts in Kazakhstan and asked for support from the IDF. Vitalii Kamynin proposed considering the possibility of using the technology for recognizing games by video and demonstrating them online in the future.

A discussion took place. The Technical Commission was instructed to deal with this issue and submit proposals at the next Board meeting.

9. Issues of the Technical Commission.

Approval of documents:

The head of the Technical Commission Antonina Langina spoke about the new tables of draws of moves and positions (780 positions for Russian draughts, 772 positions for Brazilian draughts). They are valid from January 1, 2024.
